6	The bidders are required to submit bid / offer under single stage one envelope procedure separately for each category as mentioned above, as per Rule 38(1) of Punjab Procuremen Rules, 2014.		
7	CDR / Demand Draft / Pay Order for the amount as mentioned against each bid / offer in favou of Principal Cadet College Okara must be attached with the Technical Proposals of each item separately.
