6	The bidders are required to submit bid / offer under single stage one envelope procedure, separately for each category as mentioned above, as per Rule 38(1) of Punjab Procurement Rules, 2014.		
7	CDR / Demand Draft / Pay Order for the amount as mentioned against each bid / offer in favor of Principal Cadet College Okara must be attached with the Technical Proposals of each item separately.		
8	The bids should reach by 08-07-2024 till 10:30 AM in the Office of Principal Cadet College Okara. The tender will be opened on the same date at 11:30 AM in the presence of the bidders / representatives who desire to participate in the bid opening.
